## 11 Correspondence.

- **11.1** Environment Agency Annual Programme of Maintenance. The annual programme was noted. Work would be taking place in the area from July onwards.
- 11.2 Cantley Lane Access. A resident had made a request to Highways that a permanent road block be placed on this road to prevent Traveller access. Highways had responded to say that concrete rings could possibly be placed there. It was agreed that CPC would respond to say that this was not possible as the local farmer used this road to access fields. It was noted that there had been two Traveller incidents in recent months but that no damage had been done. The Clerk would contact Highways to advise that concrete rings would not be appropriate but to request that they ensure that the padlock is always kept in place.
