#### 6.1 Big Sky (St Giles Park)

- 7.1 **Traffic concerns** correspondence had been received from a parishioner regarding traffic on Roundhouse Way / Colney Lane. Clerk to respond to advise that CPC had requested uniform speed limits across the parish but Norfolk County Council had refused. However both sides of the roundabout would be changed to 30mph once Kier had started work on their north parcel of land. A bid had also been submitted for SAM2 cameras which would monitor speed and volume of vehicles around the parish.

This had previously been raised with developers, but no suitable land had been available.
