1. To receive apologies for absence

2. To receive declaration of interests in items on the agenda

In respect of planning application 2024/0589, DM declared an interest as a neighbour.

- 2024/0589, 1A Harmer Lane Two storey side extension, replacement dormer to side, porch to front and alteration to existing dwelling. No objection, but request that the new windows are fixed in place and frosted, to prevent overlooking neighbours.
- 2024/0574 10 Softley Drive, Proposed side & rear extension, porch widening with new dormers along with internal alterations to dwelling. No objection, but request that an Arboricultural Impact Assessment is carried out to ensure the protection of the nearby trees, as it appeared likely that the tree roots would run under the foundation of the extension.

7.1 Big Sky (St Giles Park).

An update to the orchard plans was received, which included additional trees at the Parish Council's request. All of the Council's suggestions had been taken into account including where to source the trees and the type of tree protection that would be used. The plans were **approved**.

Three quotes had been received and a comparison report was provided to Councillors. Of the quotes received, only one company could provide a full service for both EV charger installation and an ongoing back-office administration and payment system which they would manage. It was therefore proposed and **resolved** that Anglia Car Charging be awarded the contract. They would be asked to take this forward with Big Sky developers.
