2. Planning Applications

2.1 **To consider the following applications:**

2021/2590 10 Tungate Crescent Single storey rear extension and internal alterations to bungalow – recommended that the Clerk should send a no objection under delegated powers.

2.2 To consider time-sensitive planning applications which have been received since distribution of the agenda

2021/2779 - Area BS9 South of Newmarket Road, Variation of Condition 2 of reserved matters approval 2018/2791 pursuant to Condition 1 of outline planning permission 2017/2120, amendments to the open space layout to accommodate the A47 upgrades – recommended that the Clerk should send a no objection under delegated powers.

2021/2623 - 6 Softley Drive, Erection of replacement dwelling. Recommended that the Clerk should send an objection and call-in request, under delegated powers. TW to circulate suggested wording to Councillors.
