### 1 Apologies for Absence

Mrs I Kirk had sent apologies that were accepted. Dr A Osborne was not present.

#### 2 Declarations of Interest

MK regarding item 9, as he works with Norwich Community Solar and TW regarding 15.3 as a neighbour of the address.

## 3 To receive questions or comments from the public

A member of the public raised a potential forthcoming planning application. Councillors advised that pre-advice could not be given by them.

### 4 To Approve the Minutes of the Meeting held on 4 June 2018

The minutes were approved and signed subject to the item numbering being amended from item 15 onwards.

### 5 To Discuss Matters Arising

- 13 Parking permit the meeting with SNC had been arranged for 11 July.
- 14.2 A meeting had been arranged for 10 July with Highways, First Bus and Councillor Chiles.
- 14.5 MW and TW reported that they had attended the neighbourhood planning meeting at South Norfolk Council. This had not been particularly useful as it had been aimed at people who had not previously been involved in the planning process.

# 8 S106 Update including football pitch at The Willow Centre

The fence had been removed. The legal process had not moved forward.

# 9 To receive an update on the possibility of a solar panels at TWC

MK circulated reports which considered the benefits of installing solar panels on TWC. It was agreed that the reports would be passed to full Council, to make a decision at the July meeting.

## 10 To discuss the potential revision of the Neighbourhood Plan

An email had been received from the Head of Planning which indicated funding would be available if the neighbourhood plan was changed. It was agreed to hold a meeting over the summer to look at options and then consult SNC to establish if a referendum would be required.

- **14.2** Hornsea Project Three Offshore Wind Farm: Notice of Acceptance of an application for a Development Consent Order. Noted.
- **14.3** Keswick Road with Intwood Road crossroads update. Cllr Canham had submitted a request that a community speedwatch be started in Cringleford to monitor speed at this junction. EPAG agreed to support this at Council.

The Clerk advised that a meeting had been arranged with Highways to consider traffic calming at this junction as part of the Parish Partnership Scheme.

- 15.7 2018/1389 Land South-west Of Newfound Farm Colney Lane, Reserved Matters details for phase 1 relating to the internal spine road with associated drainage infrastructure and landscaping (Outline Planning

Permission 2013/1793). No objection as it stands, without prejudice to the rest of the design plan and reserve matters.
