PROPOSED TRAFFIC ORDERS 2018**

The Norfolk County Council propose to make the following Orders under the Road Traffic Regulation Act 1984, the effects of which will be as follows:

**The Norfolk County Council (CRINGLEFORD,
COLNEY LANE, NEWMARKET ROAD) (PROHIBITION OF WAITING)
Amendment Order 2018**

The effect of this Order will be to prohibit vehicles waiting at any time along the lengths of road specified in Schedule 1 below. The Norfolk County Council (Cringleford and Colney, Various Roads) (Prohibition of Waiting) Variation and Consolidation Order 2011 will be amended by the addition of those lengths of roads on the commencement of this Order.

**The Norfolk County Council (CRINGLEFORD, COLNEY LANE)
(STREET PARKING PLACES) Amendment Order 2018**

The effect of this Order would be to provide street parking places on the length of the C183 Colney Lane as specified in Schedule 2 below. Vehicles will be limited to a maximum waiting time of 2 hours, no return within 1 hour on Monday to Sunday from 0800 hrs to 1830 hrs. The Norfolk County Council (Cringleford and Colney, Various Roads) (Prohibition of Waiting) Variation and Consolidation Order 2011 is amended by the addition of that length of Colney Lane as specified in Schedule 2 below.

A copy of the Orders, a Statement of Reasons for making the Orders and a plan, may be inspected at South Norfolk District Council, South Norfolk House, Cygnet Court, Long Stratton, Norfolk, NR15 2XE during normal office hours.

Any objections and representations relating to the Order must be made in writing and must specify the grounds on which they are made. In the Parish of Cringleford**

Prohibition of Waiting - At Any Time

C183 Colney Lane East Side	-	From a point 15 metres north of the centreline of its junction with the U71147 Gilbert Way southwards to a point 25 metres south-eastwards of the centreline of its junction with the A11 slip Road.
C183 Colney Lane East Side	-	From a point 57 metres south-east of its junction with the A11 Slip Road south-eastwards for a distance of 8 metres.
U71621 Newmarket Road	-	From a point of 22 metres west of the centre line

North Side		of its junction with the C183 Colney Lane eastwards for a distance of 77 metres.
U71621 Newmarket Road South Side	-	From a point of 22 metres west of the centre line of its junction with the C183 Colney Lane eastwards for a distance of 60 metres.

Limited Waiting – 2 hours no return within 1 hour
Monday to Saturday 0800 hrs to 1830 hrs.

C183 Colney Lane North-east Side	-	From a point 25 metres south-east of its junction with the A11 Slip Road south-eastwards for a distance of 32 metres.
